In this connection, point-wise information is as under:

Reply to Point No. 1:- The information sought regarding category wise vacancy details for the post of Inspector (Central Excise) under the Pune Zone, Mumbai Zone, Nagpur Zone, to be filled through the SSC Combined Graduate Level Examination 2025, is not available with this office because there are no separate vacancies reported for Pune Zone, Mumbai Zone and Nagpur Zone under CCA, Mumbai. The vacancies are reported CCA wise only, not Zone wise. Further, it is to inform that Goa Zone does not fall under CCA, CGST & C. Excise, Mumbai Zone.

However, it is to inform that total 349 vacancies in the grade of Inspector have been reported for SSC CGLE 2025 by CCA, CGST & C.Excise, Mumbai Zone.
