Sub: Notifying the GST Suvidha Kendra for biometric based Aadhar Authentication as applicable under proviso to sub rule 4A of Rule 8 of the CGST Rules,2017

The proviso to sub-rule (4A) of Rule 8 of the CGST Rules, 2017 mandates Biometric Aadhar authentication, taking photograph of the applicants and verification of documents for certain category of applicants while obtaining new GST registration. For this purpose, GST Suvidha Kendras are established across the State of Maharashtra.

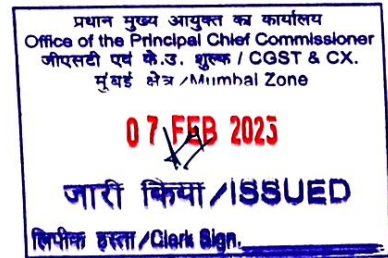
2. In this regard, the Trade & Industry are hereby informed that the details of GST Suvidha Kendra in respect of applicants falling under jurisdiction of Mumbai CGST Zone for the purpose of Biometric based Aadhar authentication are furnished in Annexure to this Trade Notice.
3. The Trade Notice shall come in to force from the midnight of 7th February 2025.

All the Principal Commissioners/Commissioners of Mumbai CGST Zone are requested to bring the contents of this Trade Notice to the notice of all the officers under their charge and Tax payers/Trade in their jurisdictions. The Commissioners are further requested to equip /sensitize all officers especially those handling the Tax payer Service Centre/Seva Kendra in each Commissionerate about the Suvidha Kendra and its location.
